

ROW Application Rules & Regulations

By signing Page 1 of this application Contractor and Owner agree to the following:

Underground:

The applicant agrees to protect all **underground** line with a casing and to place said line and casing at a minimum of (3) feet below the bottom of the ditch, to install said line and casing by auger method or push under as the County Engineer may direct, burying alongside of highway with minor exceptions, the proposed line being placed within the confines of public right-of-way at a minimum depth of 36 inches and to leave the surface to the satisfaction of the Morgan County Engineer.

Aerial:

The applicant agrees to protect said **Aerial** line with a minimum of **18 feet ground clearance** at the highest point of roadway surface when crossing all roadways. All structures being placed within the County right-of-way must maintain a **minimum offset of 8 feet** from edge of pavement for traffic safety. (Variance requests may be considered in special cases), and to leave the surface to the satisfaction of the Morgan County Engineer.

All Applicants:

- *Applicant assumes all liability for any damages, accidents, property damage or bodily injury resulting from said installation.
- *The Board of Morgan County Commissioners, by signing this, give permission to place the lines and/or cables within the confines of the County Highway Road System, only for the person, corporation, or company submitting this application.
- *NO LINES SHALL GO OVER OR THROUGH STRUCTURES AS CULVERTS, BRIDGES, ETC.
- *By granting permission, The Board does not purport to grant permission on behalf of any other person or entity having an interest in the land that may be affected and the duty of obtaining all other necessary permissions from the owner of any other interest in the land remains on the person, corporation, or company submitting this application.
- *The County shall not be liable for any damage done to any cables or lines in the ordinary maintenance of its roads. The applicant is to pay for a county inspector on the job as required by the County Engineer.
- *Your petitioner further agrees to save Morgan County harmless from all claims of damage by laying, maintaining, operating, repairing, relocating, and finally removing its lines.

The County Engineer must be notified at least (2) working days before project commencing on the actual installation.
